In accordance with AB23 it is hereby announced that the Transportation Commission/Transit Directors in attendance at today’s meeting shall receive a stipend of \$100 per adopted By-Laws.

1. TRANSPORTATION COMMISSION - Barbara O’Keeffe, Deputy Director-Transportation
  - A) The Overall Work Program Master Fund Transfer Agreement (MTFA) for planning has been received and TCTC is authorized to commence work under the new MTFA.
  - B) A Draft of the Coordinated Public Transit-Human Service Transportation Plan is anticipated to be distributed in January.
  - C) The Transit Shelter installation specifications were submitted to the Division of State Architect (DSA) with plan review scheduled to commence December 18, 2014. Also, a grant application for Rule 2:11D Indirect Source Program Funds was submitted to the Tehama County Air Pollution Control District to potentially offset the costs the shelter installation project.
  - D) The 15th Annual TRAX Tour of Corning Christmas lights is Friday, December 19th with a 6:30 pm departure from the Corning Transportation Center.
  - E) A Federal Transit Administration (FTA) 5310 grant for operating assistance will be submitted by Public Works to Caltrans.
  - F) A FTA 5310 grant for two replacement vehicles will be submitted by North Valley Services.

- G) TRAX, ParaTRAX and METS do not operate on Christmas Eve, Christmas Day, New Years Eve, or New Years Day.
- H) AB 109 Crews cleared vegetation at the Red Bluff Bus & Ride to improve safety and visibility. Crews are scheduled to do further cleaning at the Bus & Ride, Corning Transportation Center and also remove weeds from the planters in Los Molinos.
- I) January 6, 2015 is the closing date for the recruitment of a Senior Transportation Planner for the Transportation Commission/Transit Agency.
- J) The next Commission/Transit Agency meeting will be Thursday, February 26, 2015.
